Youth Violence Prevention Action Plan



We are currently engaged in the work of centering youth and community voice and expanding collaborative partnerships (Step 2).

Three of our current action plan working groups (Youth Engagement & Leadership,

Youth Employment, and Family Engagement) identified the need for intentional youth and community engagement in the process. In response, we have been working on survey development, establishing listening sessions, collaborating with other youth engagement work], developing youth focus groups, and establishing a coalition youth engagement and leadership group.
